To The Board of Directors GITA RENEWABLE ENERGY LIMITED

We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of GITA RENEWABLE ENERGY Limited ("the Company") for the Quarter ended September 30, 2022 and year to date from 1st April 2022 to 30th September 2022 (hereinafter referred to as the "Statement"), attached herewith.
